2025 Saxon Golf Outing Rates

Weekend Morning (8:00 am) Shotgun \$55pp

*Minimum number of golfers 100 (less than 100 a flat fee of \$5,500.00 is required
1 week before the outing.)*

Maximum number of golfers 140

Weekend Afternoon (1:30 pm) Shotgun \$50pp

*Minimum number of golfers 80 (less than 80 a flat fee of \$4,000.00 is required
1 week before the outing.)*

Weekday Shotgun (Monday thru Friday) \$45pp

*Minimum number of golfers 100 (less than 100 a flat fee of \$4,500.00 is required
1 week before the outing.)*

Saxon Golf Course Outing Policies

- I. **Dress Code.**
Appropriate dress is expected at Saxon Golf Course, both on the course as well as in the clubhouse. No jeans, cut-offs, swimsuits, tights, or sweatpants are permitted. Soft spikes or alternative spikes are required. If you have a question about the dress code, please ask one of our staff. The staff has the authority to refuse play or service to anyone for inappropriate dress or conduct.

- II. **Outing Cancellation Policy.**
A signed contract and a non-refundable \$500 deposit will be required to secure your outing date. If inclement weather exists, Saxon will determine playability. Rain checks will NOT be issued once the event begins.

- III. **Expected Time of Play.**
Course policy including outings, justifies a round of golf to be played in a maximum of four (4) hours and thirty (30) minutes. Saxon will monitor and a Ranger or Staff person will enforce these times

- IV. **Alcoholic Beverage Policy.**
Alcoholic beverage for your outings are not available or sold at Saxon. Alcoholic beverages brought onto Saxon property must be approved by Saxon Management prior to your event. Remember, PA law states the alcoholic beverages cannot be served to anyone under 21 years of age.

- V. **Final Count of Attendees.**
The final count of attendees who are golfing must be given to Saxon Golf Course no later than ten (10) days prior to your scheduled outing. The final count of golfers will be the number your group will be charged for the event.

- VI. **Pavilion**
For more information on Pavilion usage let us know at the time of your event.

VII. **Golf Carts**

Golf Carts used for this event are to be returned to the golf cart pickup point immediately after each golfer round is completed. All personal items should be removed along with any garbage from golf carts. No one under 16 years of age are permitted to operate Saxon golf carts.

VIII. **Sponsor Signs and Other Items**

Items can be dropped off 48 hours before the event. It is the responsibility of the outing to assemble all sponsor signs. Sponsor signs, and personal items must be removed at the completion of the event. SAXON GC will not be responsible for any personal items.

VIV. **Indemnification**

You hereby jointly and severally agree to indemnify, defend and hold Saxon Golf Course harmless from all claims, suits, actions at law, judgments, liabilities, losses and damages (including attorney's fees) arising from your use of Saxon Golf Course property, however caused, including without limitations, any injury or damages resulting from negligent, careless, improper or unlawful conduct.
